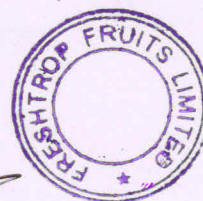

The financial results for nine months ended December 31, 2016 have also been recast as per the recognition and measurement principles of Ind-AS 34.
- The Ind-AS financial results and financial information for nine months ended December 31, 2016 have been compiled by the management after making necessary adjustments to give a true and fair view of the results in accordance with Ind-AS. This information has not been subject to any limited review or audit.
- Revenue From Operations includes Export Incentive.
- The provisions of Current Tax Expenses have been made as per prevailing Income Tax Act.
